#### PARTICIPATION

Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.

Team participation is open to all countries and limited to one team per weapon per country. All participants in the competition, athletes, coaches, officials, referees have the obligation to present a negative written result of the COVID 19 test done with a maximum of 48 hours before the start of the competition. These tests will be settled by the structures participating sports for athletes, coaches, referees and officials and by the federation for FRS officials.

According to <u>FIE requirements</u>, every participant must complete one RT-PCR test upon arrival (results will be offered in maximum 30 minutes), including for vaccinated or Covid-19 recovered participants.

In case of a positive RT-PCR test the persons will have to stay in quarantine and have to travel home immediately and contact the public health department at destination!

#### We can not offer a hotel to stay in quarantine!

Participants who receive a negative result of the RT-PCR test and who have completed and signed upon arrival the Covid-19 Acknowledgement of risk and release from liability (Appendix B) and the Screening Questionnaire (Appendix C) will get the accreditation (wristband) and will be allowed to enter competition.









### ENTRY

Open to all fencers with valid 2021-2022 FIE License.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31st December of the year preceding the year in which the competition takes place (cfo.80)

Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).

To enter the competition venue it is necessary to get an accredidation after passing the Covid19 RT-PCR test.

### ENTRY GERMANY

#### **Entry to Germany**

Participants at international competitions and members from the official delegations can enter to Germany either by an entry registration (Digital entry registration) mostly based on a RT-PCR test or rapid Antigen test not older than 72 hours, recovery from COVID less than 180 days, vaccinated with UE approved vaccines (https://ec.europa.eu/info/live-work-travel-eu/coronavirus-response/safe-covid-19-vaccines-europeans\_en).

For more information and regulations on time visit the hompage of the federal foreign office.

The athletes will present themselves at the competition hall already equipped. Every sportsman / official will come to the gym with his own backpack for storage the necessary equipment / materials;

• The number of participants will be adapted to the dimensions of the competition hall, according to the rules in force;

- Participants will follow the rule of physical distance of 1.5 m;
- It is mandatory to wear the medical mask in the competition hall by all participants;
- Officials present in the hall are required to wear disposable gloves;

• All national federations can get an individual cabine/container with more than 6 Fencers, if needed. Please inform at <u>turnier@fscjena.de</u>!

- Before the start of the competition, all equipment must be disinfected;
- All participants will follow the access circuits in the hall
- It is forbidden to eat food in the competition hall;
- The use of the locker room will be done in compliance with the principles of social distancing, allowing access to a limited number of people at the same time;
- The locker rooms will be equipped with disinfectant and will be disinfected periodically;
- Showers will not be used;

Covering the mouth or nose in case of coughing or sneezing with the elbow pad or disposable wipes and their immediate disposal, followed by sanitation immediate hand;

• Leaving the room where the competition takes place will be done in an orderly manner, in order to avoid congestion. When leaving the room, disinfect your hands again with the solution from containers at the exit of the room.









### SCREENING MEASURES FOR PARTICIPANTS

All participants will complete the COVID-19 ACKNOWLEDGEMENT OF RISK AND RELEASE FROM LIABILITY (<u>Appendix B - FORMIR - COVID-19</u>)

before the event (sent to <u>turnier@fscjena.de</u> together with the registration in the competition).

• Only persons who do not show signs of Covid 19 will be admitted to the competition hall: respiratory diseases, cough, fever, difficulty breathing, loss of smell and taste, gastrointestinal disorders. People with suspected disease will be referred to a specialist consultation.

## ENTRY FEE

### Individual competition: EUR 25. Team competition: EUR 150

The entry fee will be paid online before competition either by bank transfer.

The documents required for registration are:

- nominal table targeted by the participating structure;
- scanned copies of the cards of the targeted athletes;
- statement on one's own responsibility regarding the state of health, of assuming a risk and liability (FORMIR Appendix B);

• nominal table containing the contact details of all participants (athletes, coaches, referees, officials): full name, address, telephone number and email address. This information will create a database for organizers, used in the event of a case of illness and will be put available to the Public Sanitary Directorate (DSP) for epidemiological investigation. For protection personal data of the participants, the data collected will not be disclosed to third parties with the sole exception of the national health authorities responsible for tracking of persons who may have been exposed to Covid-19 if one or several participants became ill with Covid-19 within 14 days of end of the competition.

## SPECIFIC FENCING RULES AFFECTED BY KEEPING A SANITARY DISTANCE

- The handshake at the end of the match will be replaced with a greeting;
- Referees must inform all athletes that they are prohibited: tightening hands or hugs
- (between athletes, referee, athletes / coaches, coaches / referee, etc.), shouting after a blow;
- Referees must use hand sanitizer before and after each match;
- The referee will only check the weapon (weight and stroke measurement) before the start of the match. After an action, to cancel a touch during the assault, the referee will only test the weapon;
- In case of injury, only the doctor, as well as the medical staff of the competition can approach the injured athlete and must wear a mask and gloves;

• Athletes are exempt from wearing a face mask during comeback periods after exertion, a period which may not exceed 3-5 minutes.







## DISINFECTION OF EQUIPMENT AND WEAPONS AND WEAPON CONTROL

Sports material and equipment will be disinfected whenever it is possible.

Fencing masks should be disinfected at least daily. Athletes must use the PERSONAL mask. It is NOT allowed to borrow the mask!

Fencing gloves are one of the most likely items to carry the virus and must be disinfected at least once a day. Athletes must wear the PERSONAL glove. It is NOT allowed to borrow the glove!

The weapons are made of steel, a material on which the virus remains active a very long period of time. Daily disinfection of weapons is mandatory. Lending weapons is NOT allowed!

For Weapon Control:

- Mask (max. 2)
- Glove (max. 2)
- Electric jacket (max. 2)
- Breast Protection (max. 2)

## **REFEREE OBLIGATION**

Participating countries must be accompanied by referee with FIE A, B or P licenses as below (cf. t.35). Delegations not respecting the quota must pay a fine of EUR 1.000 per referee. If you need help please contact <u>turnier@fscjena.de.</u>

## FORMULA

Individual competitions: one qualifying round of pools, a direct elimination table to qualify for a final by direct elimination (cf. o.35-o.41).

Team competitions: Integral direct elimination with a direct elimination table, which may be incomplete. All places in the table up to 16th place will be fought for. From 17th place onwards teams will be classified, within each round of the table, according to their initial place in the table.

The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf.o.86); the remaining ranked teams will be placed in the table by drawing of lots in pairs. The teams that are not classified will occupy the last places in the table, and will be separated by drawing of lots (cf.o.42-o.47).

### DOPING

Doping control will be done according to FIE rules.

### **DEPARTURE TEST**

Participants needing a Covid-19 test to go back to their home country must inform the organizer's test station and make an appointment according to their departure time.

#### These tests are at the expense of participants.
