#### Rules of European Cup of Club Champions

- a) Participants should be National Club Champion Team of any European country
- b) ECCCh winner from the previous edition
- c) The Club Team of individual Olympic Games or World Championships medalists can be present, however no more than 2 team clubs from one country can participate
- d) Only fencers with national license of given club's federation can participate.

It will be guaranteed under the responsibility of the national federation, who will enter the team on the web site.

- e) Inscriptions will be possible only through the EFC website imposing deadline for inscriptions.
- f) EFC license for athletes will be required
- g) The entry fee will be fixed to 100  $\in$

h) FIE homologated standard equipment is required, including the name and the nationality on the back of jacket of fencers

i) Reception by the Organizer of Form Covid-19 acknowledgment of risk and release form liability for participants (Annex 1) is a prerequisite for registration.
